

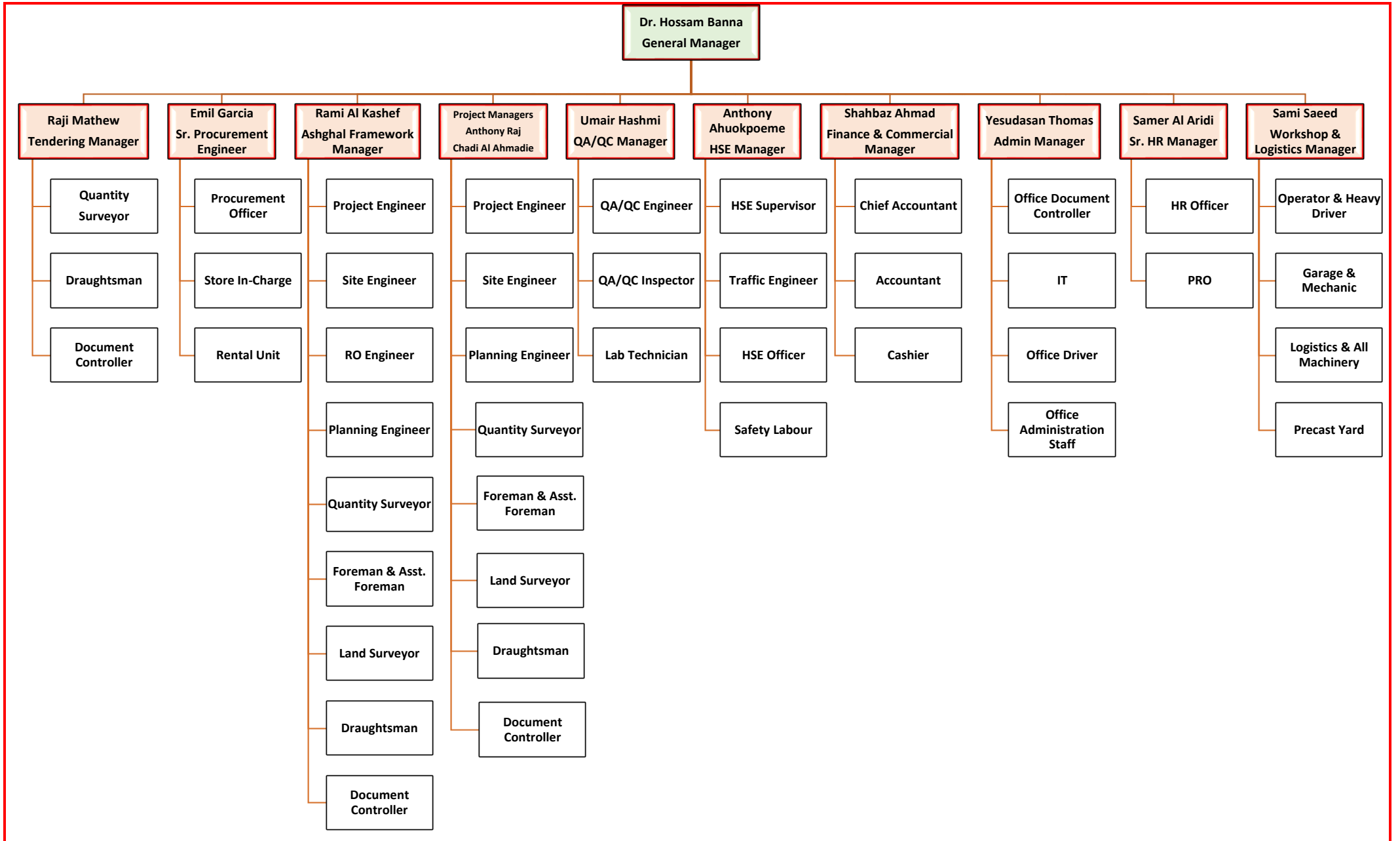

SMOKING, DRUG AND ALCOHOL POLICY

1. Purpose

- **Class C includes:** Most benzodiazepines e.g., Temazepam, Valium, other less harmful drugs of the amphetamine group, anabolic steroids, and tranquilizers.
- **Alcohol includes:** All drinks containing alcohol which can cause drowsiness and lack of sense / attention. This includes illicit drinks and liquors also.

ALCAT Management realizes that not only an individual exposed to an accident if working under the influence of drugs or alcohol but creates a potential risk to others. Smoking will not be permitted in any workplace other than designated areas.

3. Enforcement:

Possession, consumption, and entry under the influence of drugs and alcohol inside office or Project premises are strictly forbidden under this Policy. Failure to comply with this Policy will be dealt with through the company's disciplinary procedures. Visitors or members of the public who breach the policy will be asked to stop smoking and will be asked to leave the premises if they fail to comply with this request.

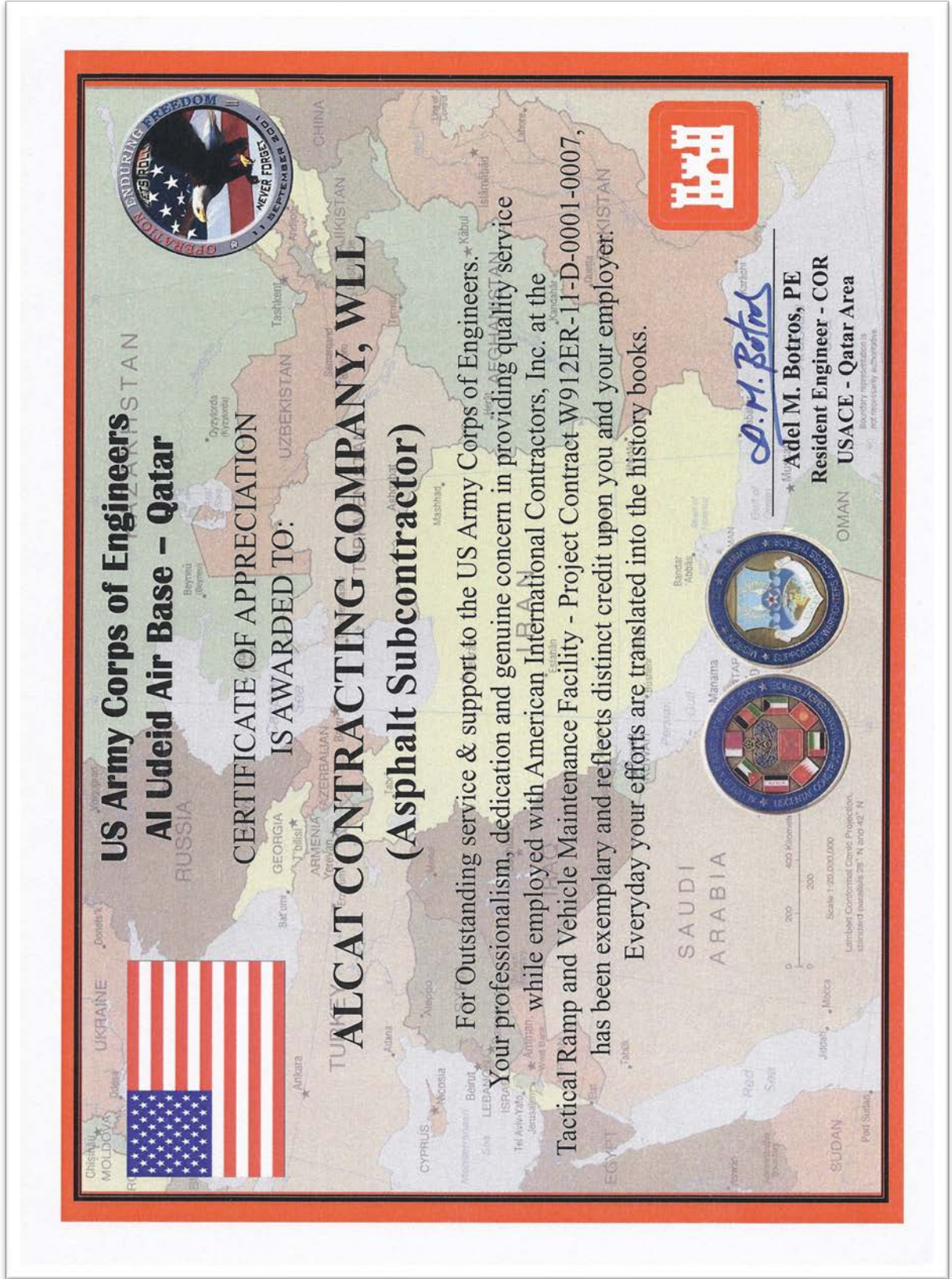
